

Annual General Meeting Treasurers Report 2bdh July 2025

1. Accounts year ended December 2024

For the year ended 31st December 2024 the balance on hand within The Moseley Forum Metro Bank stands at £1,234.45. The accounts highlight a reduction in our overall position compared to 2023 (and previous years), reflecting the loss of grant funding from Birmingham City Council.

2. Audited Accounts

A copy of the accounts for the year ended 31st December 2024 is attached (see Appendix A).

The Forum accounts are due to be signed off by the Chair and Treasurer post the AGM and are subject to independent scrutiny - The Forum has traditionally provided audited accounts, as an unincorporated association this is not a legal requirement. However, to demonstrate on-going rigor, we have sought independently adjudication to verify our reported position.

3. Highlights

Principle and major items of expenditure related to the Mayoral and General Election Hustings in 2024, and room hire and associated administration e.g. printing costs relating to the continuous cycle of public meetings sustained by the Forum on behalf of the wider Moseley Community.

4. Risks and Opportunities

Failure to secure recurrent funding is likely to lead to the demise of the Forum (within the next 12-18 months) after 25 years of representing the Moseley Community.

We understand that Neighbourhood Forums grants are to be reinstated by Birmingham City Council – we await with optimism and patience. We however understand the need to develop alternative funding streams to support the work that we do on behalf of the community – this will include retiring collections after meetings, web and app campaigns to support fund raising and donations.
